

ORDINANCE NO. 10-03

AN ORDINANCE AMENDING CONNECTION FEES AND PENALTY PROVISIONS FOR THE OREGON WATER WONDERLAND UNIT II SANITARY DISTRICT; REPEALING ASSOCIATED CONNECTION FEE AND RATE ORDINANCES AND RESOLUTIONS; AND DECLARING AN EMERGENCY

WHEREAS, the Oregon Water Wonderland Unit II Sanitary District has adopted a new Systems Development Charge effective **July 29<sup>th</sup>, 2010**; and

WHEREAS, due to the Systems Development Charge, the connection fee set for the District can be significantly reduced; and

WHEREAS, the Board must put this modification in place immediately to avoid charging both the original connection fee and the new SDC fee; and

WHEREAS, the District Board has chosen to take this opportunity to also conduct a housekeeping clean up of its ordinances and resolutions regarding maintenance and operation fees, penalties, and connection fees.

NOW THEREFORE, THE DISTRICT BOARD FOR THE OREGON WATER WONDERLAND UNIT II SANITARY DISTRICT HEREBY ORDAINS AS FOLLOWS:

Section 1. Amending Ordinance No. 02-01.

A. Sections 3.B and 3.C of Ordinance 02-01 are hereby repealed and replaced with following language:

“Prior to connection, Applicant shall pay a connection charge to the District in an amount set by Board resolution. Said connection fee shall reflect the actual or average costs to the District for said connection.”

All remaining subsections of Section 3 are hereby re-lettered accordingly.

B. Section 9 of Ordinance No. 02-01 is hereby amended to read as follows:

“Any person or persons found in violation of any provision of this Ordinance shall, upon conviction thereof, be deemed guilty of a violation and fined in an amount not to exceed \$500 for each violation. Each day in which any violation continues shall be deemed a separate punishable violation.”

Section 2. Amending Ordinance No. 09-03. Sections 2 and 3 of Ordinance No. 09-03 are hereby repealed and the remaining section renumbered accordingly.

Section 3. Repeal.

A. Ordinances No. 07-01 and Amendments Nos. 1, 2 and 5 to Ordinance No. 02-1 are hereby repealed in their entirety.

B. Resolution Nos. 02-02, 03-08, 06-06 and 06-07 are hereby repealed in their entirety.

C. Any existing ordinances or resolutions of the District which conflict with the amended monthly sewer service user charge and connection fee as established by amended District Ordinance No. 02-01 or any other provision of this Ordinance are hereby repealed.

Section 4. Emergency Clause. It is hereby adjudged and declared that existing conditions are such that this Ordinance is necessary for the immediate preservation of the public peace, health, and safety of the Oregon Water Wonderland Unit II Sanitary District, and an emergency is hereby declared to exist and this Ordinance, and all provisions modifying the Ordinances and Resolutions referred to herein, shall take full force and effect when signed by the Board President.
