- b. Resolution No. 16-01 Connection Charge – This resolution repeals Resolution No. 15-01 and will allow the District to increase the Connection Charge from \$340.00 to \$346.00. Michael made a motion to adopt Resolution No. 16-01. Bob Worthean seconded the motion, the motion carried unanimously.
